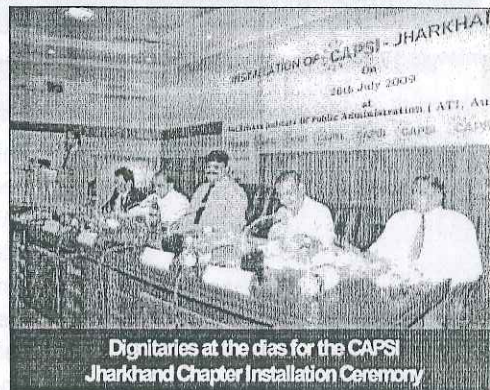

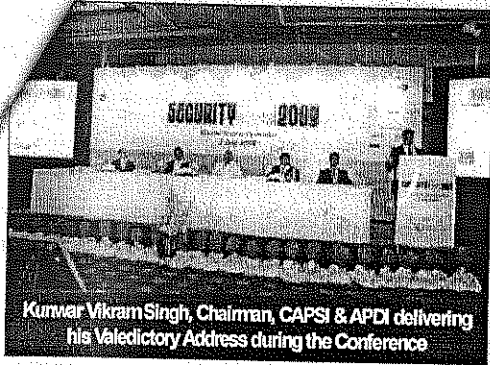
The pinning-up ceremony and oath taking were conducted with solemnity and the programme ended with the gathering reciting the national anthem.

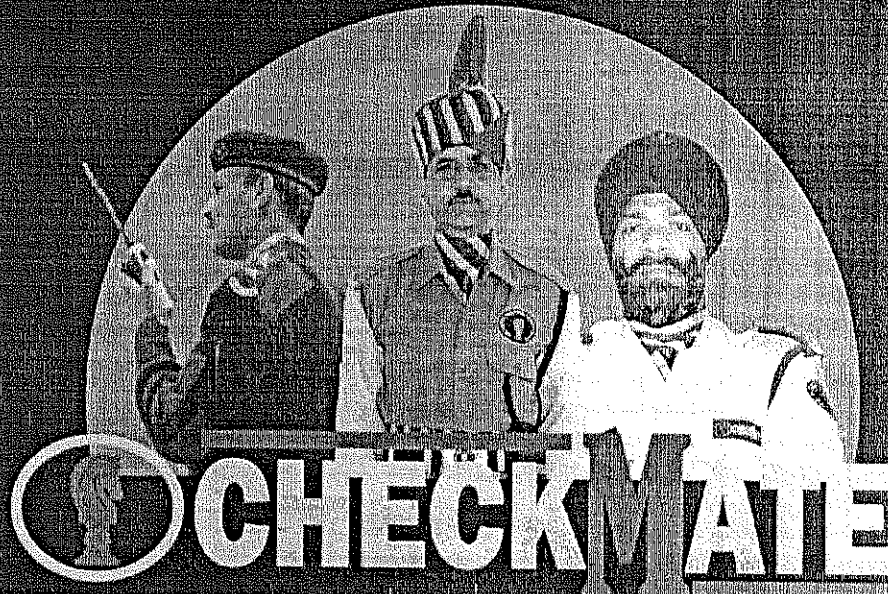

# A NEW CHALLENGE FOR THE PRIVATE SECURITY INDUSTRY

I emphasize once again, that the time has now come for imparting training to the 'People' on 'Terror Fighting' from now onwards, for Good to survive & thrive, and Bad not to become worse than ever!

'Terror Fighting' is to be done by creating 'Soldiers of Goodness' all over, and at the soonest.

And creating such 'Soldiers of Goodness' has to be en-masse, with the least amount of effort, in the least amount of time, as a very large number of People has to be prepared, and very little time is left, before more damage is done to our World at large.

Therefore, all the tools of Intelligence and Common Sense will have to be incorporated and pushed through very meticulously and deliberately, almost injected into the very fiber of the 'Good', painlessly and quietly, while the Bad watches and becomes conscious of the strengthened spread of the Goodness around him, and then either surrenders or behaves like a Good, meekly or shyly.

1% of about 15000 Security Agencies in the country is approximately 150 Security Agencies, and if these many agencies only, come forward under the banner of CAPSI, and decide to train and motivate at least 2-lac docile people per agency in 3-5 years in major affected cities to become 'Soldiers of Goodness' to be ever ready to face the 'Bad' spontaneously, thus an army of more than 3 Cro

'Soldiers of Goodness' would be raised in the country which is not an ordinary strength and will be approximately equivalent to 30 times the strength of the Indian Defence Forces put together, and readily available in major cities to counter the initial brunt of the terrorists, which will not be ordinary.

Though it may sound as a very ambitious and a somewhat far fetched suggestion, allow me debate here, there is no alternative but to adopt it..., if thorough introspection is done..., time has come for a Do or Die situation getting into place in the Nation at the micro level and the World at macro level...

Preparing People can be accordingly implemented through an Eight Point Agenda as under:

1. To Cultivate a Seventh Sense i.e. the Security Sense, amongst people, through Mass Rallies, Security Melas, and to take appropriate steps to start Security Festivals.
2. To Prepare People Aboard to counter Hijackers through Air Announcements by Air Hostesses of respective Airlines of the World.
3. To include Terror fighting in the School Curriculum.
4. To Mentally Prepare and Physically Ready the People, to take on the Bad physically and abruptly during the initial brunt of Terror Fight.
5. To conduct Security Audit of Corporate, Industries, Organizations, and Corporate Societies to check level of cultivation of the Seventh Sense i.e. Security Consciousness and Security Preparedness of People.
6. To incorporate heavy use of Tools of Security & Surveillance Equipment in public life.
7. To De-arm civilians No Gun Licenses to be granted, impose a worldwide ban, disband the illegal personal gun manufacturing industries and absolutely restrict legal personal gun manufacturing industries. To be made possible by the United Nations Organization.
8. To Graduate Terrorists in Gandhism, and only then to be released...

Point No. 1:

This will be the first and foremost call for creating total 'Security Consciousness' i.e. 'Sense of Security' amongst the People. Gone are the days when we could get satisfied with the phrase "Causing Security Awareness" among the masses, individually & collectively. The word 'Awareness' will now have to be replaced with the more appropriate, direct and befitting word "Consciousness i.e. Sense" when it comes to Security of an Individual. Therefore, lets talk of cultivating Security Sense i.e. Security Consciousness among the masses, individually & collectively and not Security Awareness.
